TERMS AND CONDITIONS

These Terms and Conditions of Service and Use of ServiceHubConnect (together with its successors and/or assigns, the "Company", and sometimes referred to herein as "we" or" us" or "our" or "Site" or "Platform") are hereby made effective, and, without waiving or otherwise releasing any right or obligation under any prior terms and conditions of the use of ServiceHubConnect hereby amend and restate any such prior terms and conditions.

SECTION 1 - ACCEPTANCE

By clicking "I AGREE" and/or simply by using or accessing our services and this Platform, you hereby agree:

- (a) that you have received, read, and understood these Terms and Conditions, and that these Terms and Conditions create a valid and binding agreement, enforceable against you in accordance with the terms hereof,

SECTION 3- REGISTRATION INFORMATION

- Service Provider takes full responsibility for all information that he/she

 information as requested by us from time to time.
- You shall remain responsible for maintaining confidentiality of this
